325. POLICY FOR DEALING WITH THE MEDIA

Subject to the rewording of paragraph 4.2 to "Confidential documents, including, but not limited to exempt Minutes, reports, papers and private correspondence should not be disclosed to the media. If such disclosures do occur, an investigation will take place to establish who responsible and appropriate action will be taken.", the addition of "for comment" after "approaches from the media" in paragraph 4.5, and the deletion of "use the term Town Councillor or" from paragraph 4.8, the policy was adopted.

326. REVISED STANDING ORDERS

Subject to the addition of "including Chairman's explanation and pertinent questions to the Chairman" being added to paragraph (iii) on page 10, the revised Standing Orders were adopted. Members asked if symbols could replace the colour coding used in the document.

327. TO CONSIDER AND AGREE ACTION ON THE PROPOSAL FROM COUNCILLOR WALKER THAT ""IN LIGHT OF THE FREE PARKING FOR WOODBRIDGE TOWN CENTRE PROVIDED BY SUFFOLK COASTAL DISTRICT COUNCIL FOR THIS CHRISTMAS PERIOD, THIS TOWN COUNCIL REQUESTS THAT THE DISTRICT COUNCIL IMPLEMENTS A 'FREE AFTER 3' POLICY FOR FELIXSTOWE FOR THE SUMMER SEASON 2014"

The Council considered and agreed to write to Suffolk Coastal District Council requesting that the District Council implements a 'Free after 3' policy for Felixstowe for the period 1 April to 1 October each year". The Clerk was asked to obtain data in respect of car park usage.
