# MINUTES OF THE ORDINARY MEETING OF THE COUNCIL

Held on Wednesday 14<sup>th</sup> August 2013 at Felixstowe Town Hall To be approved

# 147. PUBLIC QUESTION TIME

A member of the public, having thanked the Mayor for the Wings on Waves event to commemorate the 100<sup>th</sup> anniversary of sea planes in Felixstowe, asked for an explanation of what was happening with the Seafront Gardens Project. At the request of the Mayor, Councillor Smith responded that this was a Suffolk Coastal District Council project and the current dispute between Suffolk Coastal District Council and the contractor was being dealt with at Suffolk Coastal District Council.

A member of the public asked regarding rover car parking tickets why if the Town Council was in agreement nothing had happened. The Mayor responded that car parking in Felixstowe was in the hands of Suffolk Coastal District Council. At the request of the Mayor, Councillor Williams responded that she had been advised that Suffolk Coastal District Council had deferred their decision on rover tickets and were to undertake a strategic review of car parking with their draft paper prepared by the end of the year. The Mayor suggested that the member of the public may wish to write to Suffolk Coastal District Council with their views on the subject.

The Mayor referred in particular to the recent Wings on Waves event which had been a superb celebration of the 100 years anniversary of seaplanes at Felixstowe. It had been a significant and collaborative achievement involving many different local people and organisations. The sun shone, the crowds came and warmest thanks were given to all who helped to organise the event.

### 153. PLANS COMMITTEE

Items 69-80, 81-96, 111-122 and 123-133 of the meetings held on  $12^{th}$  and  $26^{th}$ ,  $17^{th}$  and  $31^{st}$  July 2013 were presented by Councillor Smith, Chairman of this Committee.

With regard to item 72 C13/1012 and C13/1013 Car Park and Hamilton House, Cambridge Road, further to a Member's request, the Chairman reiterated the reasons for the Plan's Committee's recommendation for refusal.

With regard to C13/0887 246 High Street, Walton, further to a Member's request, the Chairman confirmed that this application would be determined by the District Council's South Sub Committee for Plans.

With regard to item 74 South Seafront Land, further to a Member's request, the Chairman reported that the ongoing correspondence with Suffolk Coastal District Council in relation to the Planning Reserved Matters had now concluded, resulting in the District Council agreeing to some, not all, of the Town Council's suggested

amendments. It was pleasing that various improvements had been agreed including to the floodgates and the reintroduction of uplighters to the Martello Tower.

With regard to item 84 Suffolk Coastal District Council Planning Service, further to a Member's request, the Chairman reported that changes to Suffolk Coastal District Council's Planning Service had taken place with the introduction of a new IT system. There was also an intention nationally to move away from hard copies and paper printing to an online planning portal. The impact of this on the Town Council was not yet known.

With regard to item 87 C13/0485 Haven Exchange, further to a Member's request, the Chairman reported, in his capacity as a member of the District Council's South Sub Committee for Plans, that useful site visits had taken place to the sites of the food store applications registered with the District Council, and in order to avoid any potential contention from any of the three applicants, the District Council had decided to hear all three applications on the same date, as yet unknown.

With regard to item 117 Orchard Bungalow, Park Avenue, further to a Member's request, the Chairman confirmed that there was an annual review of all playspace provision by Suffolk Coastal District Council.

With regard to item 122 Suffolk Coastal District Council Notice of Adoption of Core Strategy, further to a Member's request, the Chairman reported that following its formal adoption by Suffolk Coastal District Council on 5<sup>th</sup> July 2013, the Core Strategy had become a planning document fundamental for all district planning decisions, and the next step would be working towards a site specific area action plan.

With regard to item 132 proposed pedestrian bridge over railway line in the vicinity of the Felixstowe Academy, further to a Member's request, the Chairman reported the Plans Committee's preference for the ramped bridge option, albeit more expensive.

**RESOLVED** that with these comments the report of this Committee be approved.

### <u>Item 146 – Review of Town Council arrangements with Suffolk Coastal Services</u>

IT WAS RESOLVED in this instance to fund the repair of the two benches in the Crescent Road car park for the sum of £186.43 from the environmental fund, however Suffolk Coastal Services should be advised that Felixstowe Town Council would not accept responsibility for the future repair and maintenance of all benches in the town.

**RESOLVED** that with these comments the report of this Committee be approved.

## 156. TOWN COUNCIL MEMBERSHIP OF SUFFOLK LIBRARIES

Following full discussion at the meeting of the Finance and General Purposes Committee on 31<sup>st</sup> July, Members considered the recommendation for the Town Council to apply to Suffolk Libraries IPS Ltd to become the member for Felixstowe.

It was **RESOLVED** that Felixstowe Town Council should apply to become the member for Felixstowe of the Suffolk Libraries IPS for the sum of £1 from the Community Fund, on the understanding that such membership would not require, imply or include a financial contribution from the Town Council of £5,200, and for the Town Council's nominated representative to be Councillor Sennington, with Councillor Walker as nominated substitute.

### 157. ELECTORAL REVIEW WORKING PARTY

Following discussion at the meeting of the Finance and General Purposes Committee on 31<sup>st</sup> July 2013, Members discussed again the establishment of an Electoral Review Working Party in order to consider matters of relevance to the Electoral Review of Suffolk Coastal by the local Government Boundary Commission for England and to determine a response from the Town Council to the consultation exercise. Recognising the time constraint for response to the consultation and the Town Council's meeting schedule, in the interests of expediency:

It was **RESOLVED** to establish an Electoral Review Working Party including representation of one Councillor per Town Council Ward (East Ward – Councillor Newman, South East Ward – Councillor Smith, North Ward – Councillor Deacon, South Ward – Councillor Jon Garfield, West Ward – Councillor Barber), and to give delegated authority to the Electoral Review Working Party in view of timescales, with any action of the Electoral Review Working Party to be ratified by the next meeting of the Finance and General Purposes Committee on Wednesday 18<sup>th</sup> September 2013.

## 158. PERSONNEL COMMITTEE

Members considered a paper from the Clerk regarding the proposed establishment of a Personnel Committee. Councillor Smith proposed and Councillor Slemmings seconded that the Town Council adopt arrangements as set out in the paper. Councillor Deacon proposed and Councillor Sharman seconded an amendment to the paper regarding Committee membership, such amendment not being passed on a vote. Following further discussion

It was **RESOLVED** to establish a Personnel Committee comprising the Mayor (ex officio), the Deputy Mayor (ex officio) and the Chairman and Vice Chairman of the Finance and General Purposes Committee.
