MINUTES OF THE ORDINARY MEETING OF THE COUNCIL

Held on Wednesday 5th June 2013 at Felixstowe Town Hall

58. PUBLIC QUESTION TIME

A member of the public representing ABLE Felixstowe asked, having confirmed that this group were on the point of entering into an agreement with Suffolk Coastal District Council for the reopening of The Leydens, whether the Town Council would support ABLE Felixstowe and visit the site once it had reopened. The Mayor responded by offering congratulations to the group for its progress thus far and confirming in principle the Town Council's support and receptiveness to an invitation to visit.

59. PRAYERS

The meeting was opened with prayer by Reverend David Kemble, Trinity Methodist Church.

60. APOLOGIES

Apologies for absence were received from Councillors Barber, Slemmings, Smith, Stokell and Williams.

61. DECLARATIONS OF INTEREST

Councillors Bird, Deacon, Jan Garfield, Morris, Savage, Sennington and Sharman declared a Local Non Pecuniary Interest as Members of Suffolk Coastal District Council.

Councillor Newman declared a Local Non Pecuniary Interest as a Member of Suffolk County Council.

With regard to the accounts, as previously declared.

Councillor Newman declared a Local Non Pecuniary Interest as the Lead Cabinet Member at Suffolk County Council for Roads and Transport (and no longer for Children and Young People).

64. ANNUAL ACCOUNTS OF FELIXSTOWE TOWN COUNCIL FOR THE FINANCIAL YEAR 2012/2013

Further to Minute ref 33 of the Finance and General Purposes Committee report of 22nd May 2013, Members considered the annual accounts of Felixstowe Town Council for the financial year 2012/2013. The Clerk drew Members' attention, in conjunction with their consideration of the annual accounts for the financial year 2013/13, to the report of the internal auditor for the financial year 2012/13. The Clerk reported that spot checks and cross checks were found to be in order. The Clerk confirmed that preparation of an investment policy was in progress. The Clerk clarified two queries which had arisen at the Finance and General Purposes Committee meeting, both of which related to the classification of a type of expenditure and neither of which affected the bottom line.

Following discussion, it was unanimously

RESOLVED that Felixstowe Town Council accept and approve the annual accounts of the Town Council for the financial year 2012/2013 appended to these minutes.

65. ANNUAL GOVERNANCE STATEMENT FOR THE TOWN COUNCIL'S EXTERNAL AUDITORS FOR THE FINANCIAL YEAR 2012/2013

Further to Minute ref 34 of the Finance and General Purposes Committee report of 22nd May 2013, Members considered the Annual Governance Statement for the Town Council's External Auditors for the financial year 2012/2013. The Clerk drew Members' attention to the restatement of a figure by a discrepancy of £10.11 as highlighted in the report by the internal auditor for the end of year account 2012/13.

Following discussion, it was unanimously

RESOLVED that the Annual Governance Statement for the financial year 2012/13, appended to these minutes, be approved and duly signed and that it be forwarded to the Town Council's External Auditors.

66. PLANS COMMITTEE

In the absence of both the Chairman and Vice Chairman, Items 12 - 14, 20 - 28 and 43 - 57 of the meetings held on 13^{th} , 15^{th} and 29^{th} May 2013 were presented by Councillor Webb, Member of this Committee.

With regard to item 14 of the meeting of 13th May 2013, in relation to C13/0485, Haven Exchange, Felixstowe, further to a Member's request, Councillor Bird clarified the request to reduce the percentage of comparison goods space included in the proposals.

With regard to item 22 of the meeting of 13th May 2013, South Seafront – Reserved Matters, Councillor Sharman expressed concern at the proposed changes which had been considered at that Plans Committee meeting. The Clerk confirmed that a response had been sent to Suffolk Coastal District Council, with their response awaited.

With regard to item 49 of the meeting of 29th May 2013, McCarthy and Stone Development, Hamilton Gardens, it was clarified that the correspondence from a member of the public related to a concern regarding the potential use of the Suffolk Coastal District Council owned Ranelagh Road car park for car parking associated with the development, and it was confirmed that the Town Council was not party to any discussions which may or may not be taking place between the developer and the District Council.

With regard to item 51 of the meeting of the 29th May 20132, Footpaths 33 and 34 Footpath Extinguishment Order 2013, it was confirmed that this related to Cavendish Park footpaths and was to regularise a previous anomaly when the footpaths were originally established.

RESOLVED that with these comments the report of this Committee be approved.

<u>Item 33 – Annual Accounts of Felixstowe Town Council for the Financial Year 2012/2013 and Item 34 – Statement of Assurance for the External Auditor for the Financial Year 2012/2013</u>

Items 33 and 34 had been discussed and agreed at Minute ref 64 and 65 of these Council Minutes. Members wished Finance staff involved in the preparation of the annual accounts and annual return to be thanked for the hard work involved.

Item 35 - Occasional Grants - Music in Felixstowe

Members considered additional financial information received from Music in Felixstowe in support of their request to the Town Council for financial assistance in putting on two concert performances in Felixstowe to mark the Benjamin Britten Centenary, and to revive the Felixstowe Folk Festival in August. Members discussed the importance of such musical events in the town, and the figures provided. Following discussion, it was

RESOLVED to provide £500 to Music in Felixstowe for the Britten performances and the Felixstowe Folk Festival from the Felixstowe Enhancement and Promotion Fund.

It was also acknowledged that the annual budget sum of £1,600 for occasional grants was a relatively low amount in the Town Council's budget, hence the funding in this instance from the Enhancement and Promotion Fund, and it was recommended that this level could be reconsidered as part of the Council's budget setting process for next year. It was noted that the Council's reserves could also be a potential source of such funding should Members deem this appropriate.
