5. In the event of a strike, civil commotion, unavoidable accident or any other cause beyond its control, The Company will refund an appropriate part of the payment, but shall not be held for any consequential or other loss or damage.
6. The Company cannot accept responsibility for any delays in obtaining manufacturers parts.
7. This agreement will continue for a minimum period of one year. We will contact you before the expiry date to determine the level of cover required for the following year.
